For over three decades, Lisa Jaubert has advised U.S. based public and private energy companies on transactional matters, largely focused on representing independent upstream oil and gas companies with assets in the Gulf of Mexico. - Regularly advised the Stone Energy board of directors and its committees, including the board's compensation committee (annual compensation, annual proxy statement and special compensation arrangements associated with reorganization and sale of the company), its nominating and governance committee (director nominations and onboarding, succession planning and general governance considerations) and the board's special committees created to evaluate strategic alternatives.
- While with Stone Energy, and commencing with the decline in commodity prices in late 2014, Lisa coordinated and managed all legal aspects of the company's varied efforts to address the effects of these significant price declines, which efforts lead to negotiations with unsecured noteholders, secured creditors and other stakeholders and concluded in a pre-arranged Chapter 11 bankruptcy filing, with an auction sale of the company's Appalachian Basin assets. Upon the company's exit from bankruptcy in February 2017, Lisa continued to support the company and its new board of directors, and to work with the company's executive team and its financial and legal advisors, to assess strategic alternatives, culminating in the sale and merger of the company in May 2018.
- Lisa joined Mariner Energy, Inc. in 2005 to support the company's acquisition of the Gulf of Mexico Shelf assets of Forest Oil Corporation and associated going public on the NYSE. As Assistant General Counsel and Assistant Secretary with Mariner, among other matters, Lisa supported the deepwater team on the company's Gulf of Mexico deepwater projects (including the Bass Lite tie-back to Devil's Tower and the Geauxpher Prospect), advised on offshore and onshore asset acquisitions and divestitures; provided counsel on the company's borrowing base revolving credit

facility; advised on all offshore regulatory matters (including legal compliance matters arising from the Macondo/Deepwater Horizon event in 2010).

• Mariner Energy counsel during the sale and merger of the company into Apache Corporation in late 2010.

#### Private Practice
